ASSUMPTION OF RISK AND LIABILITY FOR RECREATIONAL DIVING AND/OR COMPETITION.  
READ CAREFULLY THEN SIGN.

I, (print name) \_\_\_\_\_, hereby affirm I am a certified scuba diver, or I am qualified to enter as a free diver, and I am in a good state of health and capable of participating in the event for which this assumption of risk is prepared. I am aware of all inherent dangers of scuba diving and underwater sports and am aware of the basic safety rules for underwater activities and the basic rules for underwater sports. I desire to participate in the Gulf Coast Reef Hunter Spearfishing Tournament.

I understand the purpose of the event is strictly recreational and it is not the function of the organizers to serve as guardians of my safety. I understand that weather conditions may change rapidly, and that the organization, organizers and sponsors of the Gulf Coast Reef Hunter Spearfishing Tournament (the "ORGANIZERS") are in no way responsible for my decision to head out and participate in this event. The ORGANIZER's decision to NOT cancel the tournament does not act as an endorsement of good weather or marine conditions. I will gauge these conditions myself. I acknowledge the ORGANIZERS are in no way directing my activities, or otherwise acting as an advisor or principal.

I assume all risks not only associated with diving and spearfishing, but also boating, trailering, and/or traveling. I hereby voluntarily release, discharge, waive and relinquish any and all actions or causes of action for personal injury, property damage or wrongful death occurring to me, which personal injury, property damage or death arises as a result of engaging in said underwater sport and any activities incidental to such activities wherever, whenever or however such may occur. I do for myself, my heirs, executors, administrators and assigns hereby release, waive, discharge and relinquish any action or causes of action which may hereafter arise for myself and for my estate and agree that under no circumstances will I or my heirs, executors, administrators and/or assigns prosecute or present any claim for personal injury, property damage or wrongful death against the ORGANIZERS for any of said causes of action, whether the same shall arise by the negligence of any said persons or organizations or otherwise.

It is my intention by signing this document, to exempt and relieve the ORGANIZERS from liability for personal injury, property damage or wrongful death caused by negligence or any other reason. By signing this document, I acknowledge that I assume the risk of personal injury, property damage or wrongful death upon myself. THE UNDERSIGNED, FOR MYSELF, MY HEIRS, EXECUTORS, ADMINISTRATORS OR ASSIGNS AGREES THAT IN THE EVENT OF ANY CLAIM FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH SHALL BE PROSECUTED AGAINST THE ORGANIZERS OF THE GULF COAST REEF HUNTER SPEARFISHING TOURNAMENT, I SHALL HOLD THEM HARMLESS FROM ANY AND ALL CLAIMS OR CAUSES OF ACTION BY WHOMEVER OR WHEREVER MADE OR PRESENTED FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH. I understand and agree I am participating in this activity voluntarily and agree to be completely responsible for my own actions. I hereby declare I am of lawful age and legally competent to sign this Agreement, that I understand the terms herein are contractual and not a mere recital and that I have signed the document of my own free will.

I also release the use of my name and any photographs, videos, or any other information given during this tournament to be used by the ORGANIZERS of the GCRH tournament as they see fit.

I ACKNOWLEDGE THAT I HAVE READ THE FORGOING PARAGRAPHS AND FULLY UNDERSTAND THE LEGAL RIGHTS I AM GIVING UP BY SIGNING THIS DOCUMENT AND THAT I HAVE FULLY INFORMED MYSELF OF THE CONTENTS OF THIS AGREEMENT BY READING IT BEFORE SIGNING IT.
